SPIRIT YOUTH GROUP

The Safeguarding Office has launched a new Diocesan Youth Group called Spirit; a dynamic, exciting and motivational youth group aimed at 15/16 year olds. The framework is devised to encourage team work, positive peer support, friendship and a supportive value ethos.

Spirit is currently being piloted in the Wexford Branch of the Diocese and have enrolled 60 members and 20 leaders. The group are currently setting up workgroups within the parish community such as Able/Disable, Special Olympics, Nursing Homes, Tidy Towns, etc. Spirit members will also take part in a 10 week Personal & Spiritual Development Course. All successful members will receive a Certificate of Achievement by the Diocese of Ferns.


2016/2017 Training Plan

NEW DIOCESAN STANDARDS

The revised Standards and Guidance document will be comprised of an overarching policy, to be adopted across all dioceses and religious orders, congregations and missionary societies. This sets the commitment to safeguarding children; responding to and reporting

allegations, caring for the complainant and supporting and managing the respondent. It is based on Gospel values, civil and international legislation and lessons from the past.

The Induction to the Revised Policy and Standards is scheduled to take place in February and will be attended by members of the Safeguarding Office and Safeguarding Committee as well as the Designated Person for the Diocese. This will inform our training programme for 2016.

Clergy Workgroup

The Clergy Workgroup was set up in 2014 to support the Safeguarding Office in discussing 'the way forward'. The group meets 2 to 3 times a year as necessary. It has been instrumental in supporting the Safeguarding Office in initiatives such as paving the way for the Spirit Youth Group as well as highlighting the needs of the parishes within a safeguarding context. It has also provided support to the National Safeguarding Office in their exploration of the 'theology of safeguarding' and will continue to explore this topic.

This year the Clergy Workgroup will discuss the framework for the Training Programme for 2016/2017 and address questions such as safeguarding enabling Ministry. The group consists of 14 members of clergy. It is an open group and we welcome any other members of clergy who would like to be involved.
